Who will carry out your wishes about financial & health care matters when you can no longer speak for yourself? Do you have provisions in place for minor children? Every person, regardless of age or assets, should have a voice.

Through the Free Wills Clinic, Indianapolis Bar Association attorneys draft wills for FREE as a service for low-income Indy residents. Qualified individuals who meet the financial criteria (based on income, home equity and liquid assets) can meet privately with an attorney who will draft a last will and testament and advance directives for them.

## Next Free Wills Clinic Workshops

The Indianapolis Bar Association will be offering free wills and advance directive clinics for individuals whose income levels is at or below <u>250% Federal Poverty Guidelines</u>.

After reviewing the financial guidelines, if you believe you qualify, please complete this <u>online</u> <u>application</u>. Once submitted, a representative will review your application and contact you regarding next steps. Applications must be received at least five business days prior to a clinic or may be deferred to the next available date.

The physical creation of the documents takes roughly one hour and you must be able to attend in person for the execution of your final documents. Exact appointment locations and times will be communicated by IndyBar staff once application is approved.

An attorney will be available to help unrepresented parties accurately and completely fill out the necessary petitions to establish legal causes of action when a party needs to establish paternity or guardianship over a child/ren.

- The attorney will NOT represent parties in court or provide legal advice.
- The attorney will also be able to tell people about the usual course of conduct in a hearing of this type, so they have some idea of what to expect.

# What to bring?

- Any court documents related to the minor child/ren
- The names and addresses of any interested parties, including parents, guardians, and any person where the child/ren are currently living
- Any paternity affidavit or birth certificate for the child/ren, if available

Please plan to spend at least 45-60 minutes completing the paperwork and meeting with the attorney.

### What not to bring?

*Please* do not bring children and third parties who are not named within the petition as an interested party to the clinic. There is no onsite childcare; both children and unrelated parties slow down the intake and consultation process.

To obtain a legal name change in Indiana, an applicant must submit a petition to the court. The applicant must publish notice of the petition in the newspaper for three weeks and the last week's publication should be at least 30 days before the hearing. The applicant should file a copy of the published name change notice verified by affidavit of a disinterested person.

Individuals who are currently confined in a Department of Corrections facility cannot receive a name change, and individuals who are not currently incarcerated but have a felony conviction within the last ten years have additional notification requirements. (Ind. Code Ann. §§ 34-28-2-1 to 34-28-2-4).

In addition, individuals with past convictions of certain violent or sex offenses are barred from obtaining a name change for life except in cases of marriage, divorce, adoption, or for purposes of a sincerely held religious belief. In these cases, notification requirements apply. (Ind. Code Ann. IC §§ 11-8-8-23, 31-15-2-19, 31-19-2-1.1, 34-28-2-1.5).



#### What are the qualifications?

### For the minor name change forms when parents agree:

- 1. You would like to change the name of your minor child.
- 2. The minor child is not in jail or prison.
- 3. You are the parent or guardian of the minor child.
- 4. The child is less than seventeen (17) years old.
- 5. The other parent has consented, or will consent, to the name change of the child.

# For the minor name change forms when parents disagree:

- 1. You would like to change the name of your minor child.
- 2. The minor child is not in jail or prison.
- 3. You are the parent or guardian of the minor child.
- 4. The child is less than seventeen (17) years old.
- 5. Consent from the other parent or guardian is not required because a court hearing will be necessary.

# For the minor gender marker change forms:

1. Child is less than eighteen (18) years old.

#### For the adult name change forms:

- 1. You would like to change your name.
- 2. You are not in jail or prison.
- 3. You are seventeen (17) years old, or older.
- 4. You are not required to register as a sex or violent offender.
- 5. You are not trying to avoid creditors.

#### For the adult gender marker change forms:

1. You are eighteen (18) years old, or older.

# For the adult name and gender marker change forms:

- 1. You would like to change your name.
- 2. You are not in jail or prison.
- 3. You are eighteen (18) years old, or older.
- 4. You are not required to register as a sex or violent offender.
- 5. You are not trying to avoid creditors.

# Indiana Driver's License Policy & Procedures https://transequality.org/documents/state/indiana

In order to update name and/or gender on an Indiana ID, the applicant must submit to the Indiana Bureau of Motor Vehicles:

- (1) If requesting a name change, a court order approving a change of name or an amended birth certificate showing the change of name
- (2) If requesting a gender change:
  - a birth certificate showing a change of gender OR
  - a form signed by a physician certifying that the applicant successfully underwent all treatment necessary to permanently change gender (State Form 55617) OR



a physician's signed and dated statement, on letterhead, that includes the language from 140 IAC 7-1.1-3 "<insert customer's name> successfully underwent all treatment necessary to permanently change <insert customer's name> gender from <insert prior gender> to <insert new gender>."

The Indiana Bureau of Motor Vehicles addresses name and gender change here.

# Indiana Birth Certificate Laws https://transequality.org/documents/state/indiana

Indiana Code allows for additions or corrections to birth certificates, but does not provide specific gender correction language. Ind. Code Ann. § 16-37-2-10. The Corrections Section of the Indiana State Department of Health Vital Records office will issue an amended birth certificate upon receipt of a court order. To apply for an amended birth certificate the applicant should submit:

- A certified court order from any valid court in the U.S. (the court order must have the person's name, date and place of birth, and must say to change the original gender of the person on the birth certificate)
- An application for a birth certificate
- A copy of a photo ID with current mailing address
- A check or money order with applicable fees ISDH

General information from the Department of Health about amending birth certificates is on their website here.
